Horse Sale- 104 horses are for sale. Preview day will be August 29th. There will be a "thank you" BBQ that Ervin Miller puts on after the preview show. There will be food vendors down there along with the Amish ladies selling their products. Advertisements for the horse sale fell on Ervin Miller to get that out.

Camper sites at the fairgrounds – Open all year round. Horse stalls are \$25 per animal per night. Camping is \$40 per day with electrical.

Old Business: Summer Nights - The 2nd event got rained on and fire got called on a call and had to stop the First Responder event. The band J.J. Kent and 8s band were hard to work with. Amber did not have a total of participants. The other two bands said they would come back next year if we were having it. Bruce mentioned that Shop Small did not seem to drive the traffic.
